IGES 2016 Membership Drive Reminder of Dues Payment by January 1, 2016

Dear IGES Members,

IGES would like to thank all the current members in 2015 for their continued support of the Society. The Membership Drive for 2016 started on November 1 this year and is well underway. A warm thank you to all of you who have already renewed their membership for the coming year, either at the meeting in Baltimore or via the website since. This early financial support is both vital to the Society and central to the preparations for the Toronto meeting next year.

Please allow us to remind you that the **2016** membership fee is due by January 1, **2016**. As an incentive to renew by this date, the rate has been kept at the **2015** level of **US\$130** for regular professional membership if renewed by January 1, **2016**.

The membership fee when registering on or after January 2, 2016 will be raised to US\$155, which was agreed at the Baltimore Business Meeting in October 2015.

To renew your membership for 2016, please visit http://www.geneticepi.org/membership and click the 2016 IGES membership registration/renewal link, which will direct you to the event registration page.

We would also like to remind members of the fact that membership registration and annual meeting registration has now been separate since 2014, which was decided during the 2013 Business Meeting in Chicago. This measure was taken specifically to improve the drastic financial situation that the unification of the two fees had caused. **Registration for the annual meeting does not automatically make you a member of the Society for that year**. In order to qualify for the reduced Member meeting registration rate, you must already be a current member of the Society. You may still renew Society membership *for the following year* during the Meeting.

If you already renewed your membership for 2016 at the Baltimore meeting, your receipt (for professional members) will specify "Professional 2015 IGES Member Registration-(fee includes entrance to banquet)" and "2016 IGES Professional Membership" separately. If it ONLY specifies "Professional 2015 IGES Member Registration-(fee includes entrance to banquet)", then you registered only for the 2015 annual meeting. As mentioned in the October newsletter, we will reword the meeting receipts for 2016 and beyond, in order to avoid this possible source of confusion in the future with respect to membership registration being separate.

These are the rates for 2016 membership:

- Regular member **130 USD**, if paid by January 1, 2016 (early-bird)
- Regular member 155 USD if paid on or after January 2, 2016 (approved at the Baltimore Business Meeting)
- Student member with online access to Journal 68 USD, please pay by January 1, 2016
- Student member without online access to Journal 25USD, please pay by January 1, 2016

by January 1, 2016, you will pay the same membership rate as 2015. Membership fees go up

after this date, which was decided at the Baltimore business meeting.

As a reminder for this year, IGES is a charitable and educational organization, and any

contribution provided by its members is tax-deductible as allowable by law. This can be done

along with your membership renewal process. Your continuous support of IGES is appreciated!



Thank you to all the members who cast their votes in the recent ballot. Here are the results of the 2015 Election.


We congratulate Andrew Morris on his election as IGES President in 2017. Andrew will take on the role of President-Elect in 2016.

Election of IGES Secretary July 2016 – June 2019 (Please vote – Candidate list)

All current IGES members are eligible to cast their vote in the election of a new IGES Secretary for the period of office of three years from July 2016 to June 2019, in accordance with the IGES Bylaws.

The ballot shall take place from

00:00 UTC, March 1, 2016 and last 45 days until 23:59 UTC April 15, 2016.

The results shall be published in the Pre-Conference Newsletter in May 2016.

Please find Heather's biosketch below.

In accordance with Article IV, Section 2 (Election) of the IGES bylaws, "Nominations for any office in the corporation can be made from the membership when supported by five members in good standing. The nominating committee (board of directors) will contact those nominated and obtain permission to place their names before the membership. An election shall be held by online ballot for the purpose of electing one of those nominated to each office."

Members shall be given the *calendar month of January 2016* in order to nominate anyone else in addition to the above-named candidate.

Your nomination along with your list of at least 5 supporters in good standing may be sent to the IGES Board of Directors.

Nominated Candidate for the Position of IGES Secretary

Heather Cordell is Professor of Statistical Genetics and a Wellcome Senior Fellow in the Institute of Genetic Medicine at Newcastle University, UK. Heather obtained her undergraduate degree in mathematics from Cambridge University followed by an MSc in applied statistics and DPhil (PhD) in mathematical genetics from Oxford University. She then spent three postdoctoral years at Case Western Reserve University in Cleveland, Ohio. From 2000-2004 Heather held a Wellcome Trust/JDRF Career Development Fellowship at the Department of Medical Genetics in Cambridge, and in October 2004 she took up a Wellcome Senior Fellowship at the same department. In 2006 Heather moved to Newcastle



University to take up the newly-established Chair of Statistical Genetics. In addition to being involved in a number of applied studies, Heather's research interests include the development of methods for detecting linkage/association (including maternal and parent-of-origin effects) using family-based data, and the modelling of effects at multiple disease loci (including interaction effects) simultaneously. Heather was previously (2006-2012) a member of the Board of Directors of the International Genetic Epidemiology Society and acted as the 2010-2011 President of the Society.
